

Copyright and Usage Agreement

The term *Babygarten Curriculum* refers to all written, digital and video content created and supplied by Babygarten, inc. to Purchasers of the Babygarten Curriculum.

The term *Purchasers* refers to organizations or individuals who purchase the Babygarten Curriculum for the purpose of presentation of Babygarten Classes.

The term *Babygarten Class* refers to the presentation of the information in the Babygarten Curriculum with or without use of the Babygarten name and logo.

1. Materials in the Babygarten Curriculum including written information, digital information and video content are protected by international copyright laws and may not be reproduced in any form or by any means.
 - A. *Exception:* Materials in the Babygarten Curriculum that include the heading "*Babygarten Handout*" or a page border MAY be reproduced for distribution to members of a Babygarten class in the context of the presentation of the Babygarten Curriculum.
2. Use of the Babygarten Video (included in the Babygarten Curriculum) is for home use and may be included in circulating materials collections.
3. The Babygarten Rhyme CD is for instructional purposes only and not intended for general distribution as a part of a circulating materials collection.
4. Babygarten grants permission to purchasers to use the Babygarten video in Babygarten classes AND programs that promote reading to babies.
5. The Babygarten Curriculum (excluding the Babygarten Video) is for the use of Purchasers only and is not intended for general distribution as a part of a circulating materials collection. Because the lesson plans and informational material are carefully integrated, using the information out of context is not recommended.
5. Use of the Babygarten Curriculum is limited to one program site or one program teacher. Purchasers with multiple sites and multiple teachers must buy one Babygarten Curriculum for EITHER each site or each teacher whichever number is the lesser.
 - Example 1:* One teacher who presents Babygarten classes at several sites must purchase one Babygarten Curriculum.

Example 2: One program site that holds multiple Babygarten classes taught by multiple teachers must purchase one Babygarten Curriculum.

Example 3: One organization that presents Babygarten classes at 4 sites using 2 teachers must purchase 2 Babygarten Curriculum packages.

6. Purchase of the Babygarten Curriculum includes a license to use the Babygarten name and logo.
 - A. When using the Babygarten name and logo, the *TM* symbol must appear by the word *Babygarten* to signify its trademark status.
 - B. Use of the Babygarten name and logo is limited to the class or program featuring the Babygarten Curriculum.
 - C. The Babygarten name and logo cannot be used on materials not created by Babygarten, inc. except in the case of promotional materials that contain details about dates, times, class content, registration information or invitations to attend a Babygarten class.
 - D. Babygarten Curriculum Volume 2 will have the same licensing agreement.
7. Purchase of the Babygarten Curriculum includes a license for unlimited use of the curriculum.
 - A. Babygarten Curriculum Volume 2 will have the same licensing agreement.
8. Babygarten, inc. will not be held responsible or liable for information distributed or communicated in the context of presentation of the Babygarten Curriculum if it is not created or supplied by Babygarten, inc.
9. The creators of the Babygarten Curriculum disclaim responsibility for any adverse effects resulting directly or indirectly from the advice, games and activities described and illustrated in the Babygarten Curriculum, or from the reader's misunderstanding or misuse of the text and/or illustrations.
